Greetings from Toulouse! We hope that you are in good health!

We are writing to give you an update regarding our 2020 Summer School programmes in the wake to the recent Coronavirus outbreak.

You will have heard that since Tuesday 17th March the French government confined the French population to their homes for a period of two weeks. Government sources infer that this may be renewed, but that the situation may return to normal by the beginning of May.

We would like to reassure you that with this outlook, and as things stand today, the TBS Summer School programs in Toulouse & Barcelona and the Joint Summer School with Ljubljana will still run.

Nevertheless, as we are unsure how long the situation will last, and because we would like to be able to encourage as many students who wish to, to still participate in the Summer School program, TBS has decided the following:

New Registration Deadlines:

Single Toulouse, Joint Toulouse & Barcelona, Joint Toulouse & Ljubljana programs:

Students requiring a visa: 1st May

Students who do not require a visa: 14th May

Barcelona Single Summer School:

Students requiring a visa: 29th May

Students who do not require a visa: 8th June

And the Good News....!

Early Bird Program Fees for all students:

All students will qualify for the Early Bird Discounted Program Fees whatever the date of their application.

NB: Specific Information

Cancellation Policy in the case of the Coronavirus Pandemic:

- If TBS is required to cancel the Summer School program, students will receive a full refund* of the Program Fees paid.
- If the student is required to cancel their participation in the Summer School program due to a travel ban from their university or government, students will receive a full refund* of the Program Fees paid.
- If the student chooses to cancel their participation in the Summer School program, the student will be refunded* the Program Fees except for the deduction of 150€ Administrative Cancellation Fees (up to 30 days before the start of the program) or 450€ Late Administrative Cancellation Fees (less than 30 days before the start of the program).
- *All bank charges incurred for the processing of refunds following a cancellation will be charged to the student as per international banking regulations.
