Having received approval from the Research, Development and Innovation Committee (CIDI), the Vice-Rectorate for Research published the

ANNOUNCEMENT OF CONTRACTS TO TRAIN RESEARCH STAFF AT THE UNIVERSITY OF THE BASQUE COUNTRY (UPV/EHU), CO-TUTORED BY THE UPV/EHU AND THE UNIVERSITIES FORMING PART OF THE IDEX BORDEAUX 2016 (REOPENING).

At the end of the application submission deadline, the Research Management Directorate of the Vice-Rectorate for Research will study the applications presented, with emphasis on the following aspects:

- a. Fulfilment by the applicants of the requirements stipulated in Condition 3.
- b. Fulfilment of the requirements stipulated in Condition 4 by people proposed as thesis directors.
- c. The presentation by applicants within the stipulated deadline of the documents indicated in Condition 10.

Having completed this procedure, the Research Vice-Rector AGREES to issue instructions for publication on the Vice-Rectorate web portal of the provisional list of applications accepted and rejected, before proceeding to the evaluation stage.

People whose applications do not meet the above-mentioned requirements or who have failed to present all of the required documents will have from 11th until 27th April 2017 (inclusive) to rectify the aspects indicated in Annex I of this decision. <u>Under no circumstances can applicants present completely rewritten application forms or documents not required.</u>

The required documentation can be presented at the General Registry of the University of the Basque Country or sent from any post office as an administrative document, i.e. by presenting the documentation in an open envelope in order that the Post Office staff may stamp the first page. All of the documents must then be sent by registered mail to:
